

2006 JavaOne(sm) Session Evaluation Drawing

OFFICIAL RULES

3. **DRAWINGS.** Winners will be selected from all completed and eligible entries, by random drawing conducted by Sun at the Conference on each of the Drawing Dates and Times listed above.
