

# 2007 JAVA ONE<sup>SM</sup> POST-CONFERENCE EVALUATION DRAWING

## Official Rules

### NO PURCHASE REQUIRED TO ENTER OR WIN

1. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the United States of America (excluding Puerto Rico) and Canada (excluding Quebec) who are 18 years of age or older as of the start of the Sweepstakes Period, who were registered attendees, speakers, or employees of co-sponsors of the 2007 JavaOne(sm) Conference ("Conference"), and who receive a **Conference Evaluation Survey** via email ("Survey"). Void where prohibited by law.

Persons in any of the following categories are not eligible to participate or win the prize(s) offered in this Sweepstakes: (a) persons who are employees or agents of Sun Microsystems, its affiliates, subsidiaries, and their service agencies and independent contractors; (b) persons who are or were engaged in the development, production, distribution of materials, prizes or drawing of winners for this Sweepstakes; (c) persons who are immediate family of (defined as spouse, parent, sibling or child, regardless of where they reside) or anyone who resides in the same household as, any person in either of the preceding categories; (d) residents of any country currently subject to U.S. embargo (see <http://www.sun.com/sales/its/countries/Embargoed.html>); and (e) employees of any government entity. Subject to all federal, state and local laws and regulations.

2. **SPONSOR:** The Sweepstakes is sponsored by Sun Microsystems, Inc., with offices at 4150 Network Circle, Santa Clara, CA 95054 and its affiliated companies ("Sponsor").
3. **AGREEMENT TO OFFICIAL RULES:** Participation in the Sweepstakes constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules.
4. **SWEEPSTAKES PERIOD:** The Sweepstakes begins at 12:00:01 a.m. Pacific Standard Time ("PST") on May 15, 2007, and ends at 11:59:59 p.m. PST on May 29, 2007 (the "Sweepstakes Period"). Entries received prior to or after the Sweepstakes Period will be disqualified.
5. **ENTRY:** There is one (1) way to enter the Sweepstakes: Eligible participants will be notified via email with instructions on how to access the Survey and deadlines. Surveys will be sent out in three categories based on the participants' Conference participation classification – i.e., "Attendee", "Speaker" or "Co-Sponsor." During the Sweepstakes Period, participants must complete the corresponding Survey that they received from Sun via email, enter their full name, title, company, mailing address, telephone number and email address in the spaces provided, and successfully submit the Survey electronically. Once you submit the Survey, you will receive one (1) entry into the Sweepstakes.

Limit one (1) entry per person or email address. Entries received by facsimile or US mail will be disqualified. Proof of sending will not be deemed to be proof of receipt by Sponsor. Illegible, incomplete or inaccurate entries are void.

6. **PRIZES:** Winners will receive a check for US\$500 payable to the individual chosen as the winner, as that person's name appears on the winning entry form. There will be two winners per conference participation classification (i.e., attendees, speakers, co-sponsors) and six (6) winners in total.

No substitution, assignment or transfer of prize(s) permitted, except by Sponsor, who reserves the right to substitute a prize with another prize of greater or equal value. Winner is solely responsible for any and all applicable fees and taxes and shipping associated with prize receipt and use. Odds of winning depend on the number of eligible entries received. All other expenses and costs not expressly listed above are solely the winner's responsibility.

7. **DRAWING:** The winner(s) will be selected in a random drawing from among all entries received by Sponsor. Sponsor's decisions as to the selection of potential winner(s) are final and binding.

The drawing will take place on or around May 30th.

8. **NOTIFICATION OF POTENTIAL WINNER(S):** The potential winner(s) will be notified by email and/or telephone within 5 days of the drawing date. If potential winner cannot be contacted within 10 days after the first attempt to contact him/her, an alternate entrant will be selected in his/her place at random from all eligible entries received. Potential winner must comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. Except where prohibited, the potential winner must sign and return to Sponsor, within 10 days of being notified, an Affidavit of Eligibility/Liability & Publicity Release (where legal) and applicable tax forms in order to claim his/her prize.
